## Application

KGS Total Clean - Daily Cleaner is an environmentally friendly, slightly alkaline cleaner for marble, granite, engineered stone, natural stone, terrazzo, ceramics, porcelain, terracotta, quarry stone, stone and concrete slabs. Suitable for walls, floors and work surfaces (kitchen tops).

## Directions for use

Apply the cleaner evenly to the surface using the spray head. Distribute the cleaner evenly with a sponge or cloth. Daily Cleaner dries on its own. Any residues can be wiped away with the supplied microfiber cloth.

For medium to heavy soils, please use KGS Total Clean - Intensive Cleaner.

## Dilution

Ready to use, do not dilute.

## Yield

Approx. 50 m<sup>2</sup>, depending on the degree of contamination, the material being cleaned, and the cleaning method.
